Summary of EHE Initiative Progress

Major Achievements

- Established Prevention Through Active Community Engagement (PACE) Program in Regions 4, 6, & 9.
- Implemented jump-start programs in four Phase I jurisdictions.
- Phase I jurisdictions developed draft community plans for Ending the HIV Epidemic.
- Making funds available and awards to enhance and expand HIV diagnosis, PrEP initiation, HIV prevention, linkage to treatment, engagement in care and viral suppression
- Developed and implemented distribution of donated Pre-Exposure Prophylaxis (PrEP) medications to uninsured, at risk individuals.
- Developed and implemented education and awareness campaign on PrEP and the HHS Ready, Set, PrEP Program.
- Development of a Data Analysis and Visualization System (Dashboard) for the Ending the HIV Epidemic initiative.
- Creating EHE collaborations with other federal colleagues HOPWA, OWH, OMH, OPA, VA
- Exploring future collaborations and policy discussions CMS, DOJ, DOL, and Treasury



EHE Jump-Start Sites

DeKalb County, GA

- Routine HIV testing in six FQHCs
- Emergency department testing in two hospitals
- Initiate opt out testing at DeKalb County jail
- Expand AID Atlanta hotline to triage new diagnoses, link to care and/or re-engage people with HIV
- Promote early ART initiation by same day linkage to care
- Expand current HIV workforce and training for those providing non HIV services in communities to high risk populations

Baltimore City, MD

- Implement POC HIV testing in emergency departments of three MedStar hospitals
- Implement on-site HIV and STD testing services to school based violence programs
- Implement HIV provider hotline
- Implement PrEP Collaborative in two new FQHCs
- Expand public health detailing to integrate HIV testing/PrEP/PEP

East Baton Rouge, LA

- Double HIV testing capabilities of five CBOs
- Implement and routinize testing in emergency departments
- Expand SSP capacity in EBR
- Newly hired CHWs work with linkage to care coordinators to identify and re-engage in care

Cherokee Nation (IHS)

- Implement a public education campaign centering on HIV care and HIV prevention
- Educate providers on the need to have discussions about the sexual health of the patients
- Identify and link to care persons who currently access CNHS and are at high risk for HIV
- Establish a robust PrEP program within the CNHS

\$1.5M Minority HIV/AIDS Funds awarded to each site to jumpstart initiative in affected jurisdictions (awards made and administered by CDC June 27, July 1 start - December 31 completion date)



EHE Jump-Start Sites Progress

DeKalb County, GA

- 30 nurses in correctional facilities trained to deliver point of care HIV testing. Additional 12 trainings for mental health clinics.
- Mobile van, and 3 CBOs using drop-in and "pop-up" testing reaching high-morbidity zip codes
- Identification of 2,500
 presumptively not-in care HIV-positive residents will be contacted through DIS for re-engagement to care
- 2 additional PrEP access points are open for PrEP service delivery

Baltimore City, MD

- Outreach team provided HIV testing at 6 SSP colocation sites
- Park West continues to provide PrEP navigation services for their clients through the support of funds for their peer navigator through EHE.
- U=U ads are running on local college campuses, social media sites, dating apps and Google banners.
- The JACQUES Journey Center had 200 youth encounters for support services.

East Baton Rouge, LA

- During 7/1/19-12/19/19, funded EHE partner agencies (5 CBOs) documented attaining 94% of HIV testing goal (0.7% HIV +);
- During 7/1/19-11/30/19, the SSP distributed 2,643 SSP kits to persons who inject drugs.
- Tele-Prep to expanded in January to offer PrEP to uninsured persons Implement and routinize testing in emergency departments
- Community Health Workers oriented police officers in 4 East baton Rouge Districts on their community engagement efforts

Cherokee Nation (IHS)

- Public education campaign centering on HIV care and HIV prevention launched
- Community Health Workers and HI case managers hired
- PrEP ECHO hub formed training for providers in Cherokee Nation. # of requests exceeded slots working with HHS and AETCs to meet additional training and support needs
- 8 Pharmacists received PrEP training and workshops for primary care physicians completed in outlying rural health centers

Two Senior Public Health Service Commissioned Corps Officers assigned to each region

- Prepare urban and rural areas to quickly and successfully implement the EHE initiative in FY2020
- Serve as public health educators and coordinators
- Engage public at public forums and community centers, increasing effectiveness and national reach of evidence based prevention strategies
- Serve as force multipliers
- Develop both short and long term action plans to:
 - Assess the communities' needs and gaps in the regions to enhance our understanding within HHS of planning and implementation issues
 - Assist HHS Regional Offices in ending the HIV epidemic activities




PACE HIV Program – Message Multipliers – PrEP/Ready Set PrEP

Ready, Set, PrEP Program: Launched



May 2019

 HHS Secretary Alex M. Azar II announced the agreement between the Trump administration and Gilead Sciences, Inc., for the company to donate PrEP medications for up to 200,000 uninsured individuals each year for up to 11 years

December 2019

The Ready, Set, PrEP program officially launched and opened for enrollment

PrEP Donation

Gilead donated Truvada for PrEP to HHS to expand access for uninsured patients in the U.S.



- Provides medication for individuals who are at risk for HIV and who are uninsured
- Donation will deliver medication to up to 200,000 people per year
- HHS bears all other costs: verifying patient eligibility, enrolling eligible patients, building a network of participating pharmacies, distributing the donated medication, and processing claims

Given the urgent need to reach those at risk for HIV, HHS has awarded Gilead a six-month contract to administer the distribution of donated PrEP medication to eligible recipients. HHS is currently conducting a full and open competition to select a longer-term contractor or contractors (proposals due Feb 24)



PrEP Distribution





- Lack health insurance coverage for outpatient prescription drugs;
- Have a valid "on-label" prescription; and
- Have appropriate testing showing that the patient is HIV-negative.

Any provider with a qualified patient can access the program

PrEP Distribution

March 2020

CVS Health, Health Mart Pharmacies, Rite Aid and Walgreens will donate their services to distribute PrEP medications at no-cost to qualified patients in over 21,500 U.S. pharmacy locations including the District of Columbia, Puerto Rico, and the U.S. Virgin Islands and through mail order.

CVS Health, Health Mart Pharmacies, Rite Aid and Walgreens will also provide patient counseling and take steps to promote patient adherence to the regimen.





Ending the HIV Epidemic: Ready, Set, PrEP

Pre-exposure prophylaxis (or PrEP) medications are prescription medications that people take daily to significantly reduce their risk of acquiring HIV through sex. PrEP can stop HIV from taking hold and spreading throughout the body. Two medications are FDA-approved for use as PrEP: TRUVADA and DESCOVY. When taken daily, PrEP is highly effective for preventing HIV from sex.

The Ready, Set, PrEP program makes PrEP medication available at no cost for qualifying recipients. To receive PrEP medication through this program, you must:

- · Lack prescription drug coverage
- · Be tested for HIV with a negative result
- Have a prescription for PrEP

 - To launch in fall 2020





Notice of Funding Opportunity

PS19-1906: Strategic Partnerships and Planning to Support Ending the HIV Epidemic in the United States – Component B: Accelerating State and Local HIV Planning to End the HIV Epidemic

Supports Phase 1 health department jurisdictions to engage their local communities, HIV planning bodies, HIV prevention and care providers, and other partners in an accelerated and collaborative process to develop plans that address the four national Ending the HIV Epidemic (EHE) pillars: Diagnose, Treat, Prevent, and Respond

- Applications submitted December 31, 2019
- Currently under review
- Review process includes reviewers from CDC, HRSA, OIDP and PACE Officers
- Feedback due to jurisdictions end of March



Centers for Disease Control and Prevention: CDC-RFA-PS20-2010

- Contains three components
 - Component A: Development and implementation of programs tailored to the four pillars of EHE (diagnose, treat, prevent, and respond)
 - Component B: Improve ability to estimate HIV incidence in selected jurisdictions to use recency-based assay testing
 - Component C: Focused funding for STD specialty clinics to increase HIV testing, linkage to care for person with HIV, increase PrEP screening and initiation
- Applications Due: March 25, 2020
- Proposed Award Start Date: late June 2020

 - Enhance screening and treatment for mental and substance use disorders in HRSA Ryan White HIV/AIDS Program funded sites through implementation research on enhancing screening and treatment of substance use or mental health disorders in the HRSA Ryan White HIV/AIDS Program.

EHE Initiative Collaborations with Other Federal Partners

Department of Housing and Urban Development (HUD) /Housing Opportunities for People with AIDS (HOPWA)

- Engage HOPWA staff in EHE site visits. HOPWA developed a list of preferred sites to attend
- Utilize a shortened version of the data resource tool to make available to each jurisdiction for use in planning. Tool includes information on
 - HOPWA funding amounts for each jurisdictions
 - Types of housing and support services funded by HOPWA
 - Number of clients and cost per client
 - Fair market rent
- Use HUD/HOPWA expertise when EHE jurisdictions propose using EHE funds for housing
- Discussions on how to engage and leverage broader HUD programs to help end HIV especially for high risk negative populations





EHE Initiative Collaborations with Other Federal Partners

OMH/OWH/OPA

- Highlighting HIV Awareness Days collaborating on message development, using Ready Set, PrEP materials, and EHE to reach providers and communities
- Discussing ways to increase awareness among professional associations, business community, academic institutions, fraternities and sororities

Department of Veterans Affairs

- Committed to supporting the Administration's goal to end HIV
- Currently serving 31,000 veterans with HIV
- HIV test offered at least once to all veterans,
- expanding HIV care using face to face and telehealth
- Rapid access to treatment and PrEP
- Combatting stigma and discrimination
- Continued dialogue and plan to share information on training and best practices between the departments

Center for Medicare and Medicaid Services

- Significant role in HIV prevention, diagnosis and treatment.
- EHE and the updated National HIV Strategic Plan are opportunities evaluate collaboration
- Prioritizing program and policies for discussion with CMS

- Potential strategic partnerships
- Engage with employer-based insurance plans to encourage HIV, testing, and improve access and initiation of PrEP
- Use of best practices leading to high quality HIV care among private payers
- Increase awareness among private practitioners and payers of EHE Initiative










