
 OIDP and CDC are working hand in hand to prioritize HIV data expediency and transparency.

Preliminary 2020 data through Q1 (Jan 2020 – Mar 2020) for linkage to HIV medical care










CDC awarded \$109M to accelerate progress in the fight to end the HIV epidemic in the U.S.

- Project Period
 - 5 years, starting August 1, 2020
- Total Award Amount for Year 1
 - \$109 million
 - Awards range from \$1.9M to \$10.6M
- Project Areas
 - Component A: 32 Health departments (\$106M)
 - Single-Funded Phase I County/Juris. (n=16)
 - \geq 2 Phase I Counties (n=9)
 - Statewide/High Rural HIV Burden (n=7)
 - Component C: 7 STD Clinics (\$3M)
 - Alabama, Arizona, Baltimore City, Missouri, Philadelphia, San Francisco, and Washington DC







EHE Implementation Program Highlights



- Under Component A of the EHE implementation program, health departments must allocate 25% of their total funds to support EHE planning and implementation by community organizations
- Health department funding recipients are required to establish a new or expand an existing EHE advisory group or committee; must be inclusive of representatives from the Phase 1 counties.
- Local planning bodies should include "new voices" that represent communities identified in Phase I jurisdictions who have not previously participated in the planning process.





EHE Jurisdictional Plans

With funding provided for local planning and implementation, jurisdictions have developed draft overarching Ending the HIV Epidemic plans for their area.

CDC continues to encourage jurisdictions to engage local stakeholders to develop/implement their EHE plans





EHE Jurisdictional Plans

- Key findings from draft EHE plans show that jurisdictions:
 - Engaged local community partners, providers, and other partners (e.g., focus groups, community advisory boards, town hall meetings, ad hoc committees, roadshows and social media) during planning process
 - Will increase or expand targeted testing efforts in non-traditional and home-based settings
 - Plan to increase access to and use of HIV self-tests or expand syringe services programs (SSPs) and harm reduction programs/services
 - Will develop or expand social marketing, media campaigns, and text messaging communication

Revised EHE plans due December 31, 2020







Community Engagement Is Critical For Ending HIV

- Community engagement:
 - Essential and paramount to the success of the EHE initiative
 - Foundational to support the development (or update) of HIV programs
 - Vital to supporting your locally designed EHE planning process, plan development, and program implementation to address the four EHE pillar strategies
 - Need "new voices" that represent communities impacted by HIV







EHE Planning Guidance for Community Engagement

- Ongoing community engagement
 - Engage with existing local prevention and care integrated planning bodies as key participants in the planning process
 - Engage directly with local community partners, including engaging new voices
 - Engage with local HIV service provider partners
- Key to success is local community engagement and support
- Engage diverse community perspectives







CDC Expectations For Community Engagement

- Will look differently across jurisdictions
- EHE planning will add to or enhance not replace
 previous planning efforts
- EHE Plans will serve as a blueprint for ongoing and upcoming implementation activities
- EHE Plans are "living documents"

- Although engagement will have to remain virtual and socially distant due to the pandemic, previous expectations for community engagement from the EHE planning funding opportunity remain in place.
 - It is expected that health departments immediately share draft EHE plans and CDC feedback with community partners.
- It is expected that as part of the EHE implementation program, new fiscal relationships with organizations serving Black, Hispanic/Latinx, and Trans and Gender-Nonconforming communities will be documented.
- Engagement activities are expected to include community partners even while the jurisdiction is adapting to COVID-19 circumstances.

- Virtual Town Hall Sessions with local EHE communities







COVID-19 Lessons to Accelerate EHE Response



- Adoption of telemedicine
 - Reaching those out of care
 - Improving retention rates
 - Concerns about the "digital divide"
- Extension of medication refills
 - 90 day fills
 - Increased home delivery

- Self Testing
 - HIV, STIs
- Reassess processes
 - Eligibility and recertification

Working with Faith Based Organizations (FBOs)

- Meeting held with metro-ATL FBOs, PACE Director (CDR John Oguntomilade), PACE COO(Mr. Harold Phillips), EHE Counties, and GA Department of Public Health
- FBOs expressed the desire for authentic engagement in strategic decision-making processes
- Partnerships should be on-going and not exclusively for awareness events
- Faith Based Coalitions should be inclusive and diverse (i.e. religious freedom; gender, LGBTQ+; race & ethnicity, etc.)



Why PAETC-NV?

- HRSA's AIDS Education and Training Center (AETC) Program supports national HIV priorities by building clinician and care team capacity and expertise along the HIV care continuum; RWPF; Neutral convener
- PAETC-NV
 - Jan. 2019- All RW Parts Summit
 - Focus on EHE
 - EHE Workgroup developed
 - June 2019- CDC 19-1906
 - Well-integrated in the HIV community, collaboration, partnerships







Community Engagement

- Statewide EHE Workgroup
- Anyone interested may join monthly video calls
- ► 60+ members, representation from 30+ organizations statewide
 - Clinics, social services, behavioral health, health districts, state HIV offices, educational groups, advocacy groups, pharmaceutical reps, all RW Parts, PLWH
 - Broad representation
 - Partner with Fast Track Cities







Ending the HIV Epidemic

Needs Assessment Data Collection Modes

- Provider Engagement:
 - Three Focus Groups
 - Provider Engagement Survey
 - Provider-in-Training Survey
- Clark County Community Engagement:
 - Nine Focus Groups
 - Community Engagement Survey







Engaging Priority Populations

Providers

- Provider engagement
 - 2 HIV provider focus groups (n=44)
 - 1 Primary care provider focus group (n=50)
 - Provider engagement survey (n=126)
 - Provider-in-training survey (n=122)
 - Utilized AETC network, faculty and contacts







Engaging Priority Populations

Community

- Men who have sex with Men (MSM), transgender women, racial minorities, people who use substance, and those who are underhoused are highly impacted by HIV in Clark County
 - 9 Focus Groups (n=94)
 - 34% MSM
 - 10.6% Transgender women
 - 41.5% Latinx/Hispanic
 - 26.6% Black/ African American
 - 22.3% people who use substances
 - 16% underhoused
 - 42.6% PLWH

- Community Survey (n=122)
 - 37% MSM
 - 13% Transgender women
 - 21% Latinx/Hispanic
 - 23% Black/ African American
 - 2% people who use substances
 - 32% PLWH

Community Engagement- Summary

- Key strategies:
 - Posted focus group and survey on CBO social media accounts
 - Advertised heavily 3-4 weeks before each focus group and then again one week prior
 - Offered gift cards and food to focus group participants as an incentive for participation
 - PAETC-NV had strong existing ties to providers and medical schools to engage providers and students in needs assessment
 - Collaboration with all HIV entities in the state
 - Also utilized rural coalitions and other community agencies not specifically focused on HIV (statewide EHE)
 - Utilize connections in the community
 - Recognize strengths brought by individuals and organizations










